
Homosexual Agenda Impact Survey



I. CWA has uncovered proof that children in grades as early as kindergarten are being taught that cross-dressing is an acceptable practice and may be encouraged.


Do you support this practice?



What kind of impact do you believe this would have on young children?




II. Homosexual teachers and activists are conducting programs in public schools that include explicit and detailed instructions on and discussions of various homosexual practices including oral and anal sex.




III. There are growing reports of increasing homosexual experimentation among teens.

Do you believe this is related to the presentation of favorable gay instruction material in the classroom?




What kind of impact does this kind of early sexual experimentation have?




IV. The overriding interest of the radical homosexual agenda is to change the moral character of our young people and the moral landscape of our nation through our schools.


Do you think this is possible?




What impact would this have on our nation and the next generation leading it?










What impact would sexual activity between minors and adults have on our children?




What impact on traditional marriage do you believe this kid of classroom instruction will have in the future?




VIII. In some school districts, parents have the right to be informed on the subjects their children will be taught and further have the right to protect their children from homosexual and other anti-traditional family propaganda.


Would you support laws requiring area school districts to obtain a parent's permission before their child is exposed to information of a homosexual nature?
