## Adopt-A-Legislator Launch—February 22

Concerned Women for America of Oregon believes prayer is crucial to the restoration of our state and nation. On February 22, 2007, CWA of Oregon will launch its sixth "Adopt-A-Legislator Program." Ninety CWA women and men from around the state have "adopted" a state legislator or judge and have committed to regularly pray for him/her and send an encouraging postcard to him/her twice a month throughout the legislative session. This is a rewarding activity that places Christians in line with God's will by praying for those in authority. I Timothy 2:1-2 says, "I urge, then, first of all, that requests, prayers, intercessions and thanksgiving be made for everyone ... for kings and all those in authority, that we may live peaceful and quiet lives in all godliness and holiness."

Think of the impact a daily prayer for a legislator might have when he/she is deciding how to vote on a pro-family, pro-life bill! Imagine how encouraging a timely-sent Scripture can be to a discouraged, Christian lawmaker! God's word is powerful. Imagine the impact in the spiritual realm when a non-believing legislator reads

## Oregon Budget Out of Control

Oregon families feel the impact of how the state chooses to spend the revenue it receives and how it chooses to generate new revenues. The decisions made by the state legislature in regards to Oregon's fiscal policy directly affect the budgets of families across the state. Dennis Richardson, Republican State Representative from District four and part of the House Republican Leadership team, is working to protect Oregon taxpayers, property owners and families. He remains steadfastly committed to finding solutions that work for Oregon families at a price taxpayers can afford. With his work in Human Services, he is especially committed to assuring that we meet the needs of Oregon's most needy and help all others to help themselves.

Below is an excerpt from an article written by Dennis Richardson entitled "Let the Spending Begin:"

*Oregon's "Governor's Recommended Budget" (GRB) for the next biennium is a record setter. Now the*

*real work begins. The GRB is based on a revenue forecast that is 20 percent higher than the current budget. What would life be like if you were given an additional 20 percent of your personal income to spend over the next two years?*

*--Unfortunately, to obtain a 20 percent increase in revenues, the Governor wants the following four additional revenue sources: 1. Raise the Tobacco Tax (\$182 million); 2. Create a new tax on auto insurance policies (\$25 million); 3. Increase corporate filing fees (\$85 million); and 4. Retain the corporate kicker (\$275 million). If the Legislature grants the Governor all of these revenue sources, the total general funds and lottery revenue pool would be \$14.9 Billion of General & Lottery Funds. It is my opinion that increasing State spending to the levels set forth in the GRB is both unwise and unsustainable.*

*Last November, Oregon's voters soundly defeated Measure 48. As you will recall, M-48 was the measure that would have imposed a restriction on the growth of State spending to an amount equal to the*

*combined percentage increases in inflation and population growth. Excess revenue would have been sent by the Legislature to a Rainy Day fund. Governor Kulongoski has taken the overwhelming defeat of M-48 as a mandate to invest in Oregon education, services,*

*and infrastructure. Such a large influx of revenue in every quadrant of state spending should help keep the economy booming over the next two years. The important questions remain: What happens to Oregon's budget after the 2007-09 "Boom-Time Biennium" is over? Can the increased level of spending be sustained?*
