

Dear Fellow Christians,

This is truly URGENT! The Maryland Legislature is preparing to pass a bill - the **Gender Identity** bill - that would allow men to dress up as women and then enter and use women's public restrooms. This is just another facet of the liberals' extreme agenda to approve of every deviant thing under the sun in the name of non-discrimination. The Maryland House bill is no. HB-474 and the Maryland Senate bill is no. SB-566. If passed by both the delegates and the senators, then these two bills will become one bill and then will become a law in Maryland.

Please don't underestimate the importance of these bills to you and your children. A woman and her little daughter can be in one stall of a public restroom while a big, burly man, who might also be a child molester/rapist/pervert, is in the next stall. Many men are much taller than women; so it is conceivable that these cross-dressing men could look right over the sides of the stall into one being used by a woman or a child. Then please take action by calling the state senate and house committees to tell them that you are strongly opposed to the **Gender Identity** bill.

For the Senate bill SB-566, call the Judicial Proceedings Committee at 410-841-3623 or 301-858-3623. All they will want to know is whether you are For or Against the bill.

For the House bill HB-474, call the Health and Government Operations Committee at 410-841-3770 or 301-858-3770. All they will want to know is whether you are For or Against the bill. They will not ask you any questions about the bill itself, so please don't be afraid.

Then call or e-mail your specific delegate or senator. If you don't know who your delegate or senator is or you need their contact information, go to <http://mlis.state.md.us> In the right-hand column and at the top of that column, click on "Find Your Legislator by Address." On the next screen, you will enter your home address. Then you will see the names of your delegate with all of his/her contact info and also the name of your state senator with his/her contact info. You can click on "send an e-mail" or you may choose to call. If you e-mail, just simply say that you are asking him or her (use their names) to vote NO on the Gender Identity bill. PLEASE DO THIS TODAY.

If you have trouble finding the contact information, or if you live in Southern Maryland, please e-mail me and I will provide the information to you.

ALSO: Please call the Maryland Retailers Association at 410-269-1440 and ask them to withdraw their support for the Gender Identity bills.

Time is of the essence. If we wait until this bill becomes law, then there is nothing we can do about it but live with it. The time to act is NOW.
