Dear Friends,

On behalf of Concerned Women for America (CWA) of Illinois, we send you greetings of peace and joy this Christmas season. Jesus is the reason we celebrate! Let us be reminded that it is in Him in whom we place our hope, for on His shoulders, He bears the burden of both peoples and governments.

“For a Child is born to us, a Son is given to us. The government will rest on His shoulders. And He will be called: Wonderful Counselor, Mighty God, Everlasting Father, Prince of Peace.”

This year has been an extraordinary year with the election of President Donald Trump and Vice President Mike Pence. The Lord has been invited back into the White House, the economy is booming, religious freedom is being restored, and the United States has officially recognized Jerusalem as the capital of Israel.

Sadly, here in the great state of Illinois, the following became law or policy despite intense lobbying efforts by CWA of Illinois and other conservative organizations and churches:

- The **Illinois Tax-Payer Funded Abortion Bill**, H.B. 40, which recognizes babies in the womb as “non-human,” is now the law of the land.
- The **Transgender Birth Certificate Bill**, H.B. 1785, signed into law by Gov. Rauner, makes it legal for transgender men and women to acquire falsified birth certificates with their “designated sex and name change” with or without a sex change operation.
- The **Illinois Department of Child and Family Services** now requires the acceptance of the lesbian, gay, bisexual, transgender, and queer/questioning lifestyle by ALL social workers and foster families. Failure to adhere to these new policies will result in dismissal from one’s role.

On the positive side:

- After 16 attempts, the **Equal Rights Amendment** (ERA) is dead for this session and hopefully has breathed its last in Illinois.
- **Recreational Marijuana** was not voted upon during this session; therefore, it remains illegal.
- **Gambling expansion** was tabled for now.
