## No More Delay — Confirm Kavanaugh Now

- Judge Brett Kavanaugh is an [exemplary candidate](#) with the highest qualifications to serve as the next Justice of the United States Supreme Court.
- He currently serves on the D.C. Circuit Court of Appeals (known as the nation’s second most powerful court) where he has [authored](#) more than 300 opinions.
- He is an impartial jurist who is highly regarded by legal scholars on [both sides](#) of the aisle. Even the liberal American Bar Association [gave him](#) their best rating of “unanimously well qualified” to sit as the next justice of the Supreme Court.

- Noticeably, Ford is a left-wing professor with close [ties](#) to the [Democratic Party](#). She first provided the letter to Democratic Sen. Dianne Feinstein and to the left-leaning *Washington Post*. She is also coordinating with a whole team of Democratic operatives who are advising her on how to handle her allegations.
- Also of note is the fact that Sen. Feinstein received that letter in *July* and [withheld it](#) from Republicans all throughout the hearings. She did not even use it during a private session that they always have with the nominee. Only when a vote was scheduled after the hearings was the letter published in the press in order to delay the committee vote. And they succeeded. A hearing is now [scheduled](#) for Thursday, further delaying the vote.

- Democrat Sen. Mazie Hirono (D-Hawaii) has revealed their [sinister plan](#). They are hoping to stall and delay until after the mid-term elections where they hope to regain control of the Senate and then have enough votes to bring down Judge Kavanaugh.
- The whole motivation behind this is, of course, the fact that they know Justice Kennedy, whom Kavanaugh is set to replace, was the so-called “swing vote” on a whole host of issues that the left adores. Chief among them is their veneration of [abortion](#).
