Year in Review

2018 began with CWA of Hawaii attending the March for Life at the Hawaii State Capitol in Honolulu. It has been a joy to participate in this event since I became State Director nine years ago.

This year's legislative session was more challenging than usual. State legislators who do not hold our values were more aggressive in their attempts to pass legislation that does not align with CWA's core issues. CWA of Hawaii took a strong stance against several pieces of harmful legislation. We stood *against* assisted suicide, *against* the prohibition of conversion therapy, and *against* a mandate that would have forced pregnancy centers to provide information about abortion providers. Thankfully, this last piece of legislation was ruled unconstitutional by the Hawaii Supreme Court. Sadly, we were not as fortunate with the outcomes of the other pieces of legislation.

We proudly supported CWA's national effort to encourage Brett Kavanaugh's confirmation to the Supreme Court. Though an unbelievable fight, CWA of Hawaii did its part through prayer, sending e-alerts, and writing a letter-to-the-editor titled *Flimsy Accusations Shouldn't Count as Fact* that spotlighted Sen. Mazie Hirono (D-Hawaii).

We once again ran our vital Encourage-A-Legislator program in which volunteers supported legislators with both prayer and sending encouraging postcards throughout the legislative session. 25 legislators were adopted this year.

We are excited to report that another Prayer/Action Chapter was started in Hawaii, this one by Fern Mossman in Kailua. She has been diligently working to grow her group and encourage both prayer and action on national, state and local issues as the group meets once a month. Thank you, Fern!

As State Director, I continue to stand in protest as often as I can at the Hilo Community Surgery Center where they perform abortions approximately five days per week. CWA of Hawaii also

joined other participants in front of Honolulu's Planned Parenthood on the first day of the 40 Days for Life fall campaign. What a joy it continues to be to support the prayer efforts of this wonderful ministry.

CWA released a new brochure titled *The Constitution is NOT the Problem* which addresses the issue of an Article V Convention.

In October we hosted our first of many CWA of Hawaii sex trafficking meetings. The October meeting was held in New Hope Puna. There are plans to have more meetings on this issue on the other islands of Maui, Kauai, and Oahu, as well as on the Kona side of the Big Island. Our goal is to increase awareness of this horrible industry in Hawaii.
