Concerned Women for America of Kansas, as part of the nation's largest public policy women's organization, has had a very busy year! Let me share a few highlights that YOU made possible as you prayed, you took action, and you financially supported us throughout 2018.

Impact 2018

CWA of Kansas State Conference

We began the year with Impact 2018, CWA of Kansas' *first* state conference. It was phenomenal! We were thrilled to have over 70 in attendance. We received great feedback.

The event started with a *Meet & Greet* at the state capitol where we had a continental breakfast with our legislators and Gov. Jeff Coyle. We enjoyed good food, fellowship, and networking.

We then went to a nearby church where we were encouraged, inspired, and educated by incredible speakers. We had CEO and President of CWA Penny Nance, National Field Director of CWA Janae Stracke, Secretary of State Kris Kobach, Kansas Attorney General Dereck Schmidt, State Rep. Ron Highland (R-District 51), President of Kansans for Life Joe Patton, Executive Director Topeka Rescue Mission Barry Feaker, State Sen. Caryn Tyson (R), and State Rep. Susan Humphries (R-District 99). They spoke on an array of issues such as the *Adoption Protection Act*, legislation concerning the trafficking issue, the wonderful work that the Topeka Rescue Mission is doing to rescue trafficked victims, state pro-life strategy, the value and need for conservative women in the public policy arena, and more.

The conference concluded with an introduction of our Feisty & Feminine Workshops based on Penny's book, *Feisty & Feminine: A Rallying Cry for Conservative Women*. Attendees were encouraged to host a workshop in their area with the goal of having workshops all across the state. (More about the workshop on the next page.) Penny then honored us with a book signing.

Capitol Influence

Through the legislative session we took a stand on the Adoption Protection Act, HB 2687, and Choose Life license plates, HB 2678. **Praise be to God, both were signed into law.**

HB 2687 was greatly needed in Kansas. If it hadn't passed, it would have left our adoption agencies open to lawsuits and legislation that would force faith-based adoption agencies to adopt out to same-sex couples or shut down. This had already happened in several states and we were not going to let Kansas be next. We attended several meetings at the

capitol, had Rep. Humphries speak to our conference attendees on the issue, and put out several e-alerts encouraging members to pray about the issue and then to contact their legislators in support of HB 2687.

HB 2678 now allows the state of Kansas to issue special pro-life license plates. CWA of Kansas assisted Rep. Jacobs (R–District 4), the sponsor of the bill, with research and [testified before the House Transportation Committee](#) in favor of the bill.

Encouragers are needed ASAP to be part of CWA of Kansas's Encourage-A-Legislator (EAL) program. The goal of the EAL program is to encourage each member of the Kansas House and Senate by praying for them on a regular basis and sending them a postcard every week throughout the legislative session. The Kansas Legislative session starts in mid-January and usually ends in late March or early April. We hope to cover all those "in authority" in Kansas; 125 House members, 40 Senate members. This program is never used to lobby, it is simply a great way to lift up those in authority and encourage them in their responsibilities.

We provide the name and address of the assigned legislator(s) and the post cards and you commit to praying for your individual(s) every Monday morning the Kansas Legislature is in session and then mail a pre-printed EAL postcard on that day.

Information is power, and we at CWA of Kansas strive to provide you with information with which you can act upon. However, we know that without prayer our efforts to inform and influence can be without effect. We also know that those whom God has allowed to be placed in positions of authority need our prayers for wisdom and direction regardless of whether they are conservative or liberal. CWA of Kansas plans to deliver those prayer! Please join us!
