What a whirlwind it has been since September when President Trump's nomination of Judge Brett Kavanaugh was announced in July followed by heightened midterm elections! Both sides knew these two events had the potential to impact our nation for generations to come; therefore, they put forth their all.

We watched as chaos erupted during Judge Kavanaugh's nomination continuing through the midterms. Disappointment followed when more conservatives were not elected to state and national races; yet, we thank God that Justice Kavanaugh now sits on the U.S. Supreme Court and are also grateful to have a Senate majority that respects the Constitution, especially relative to judicial nominations. Read [CWA's November 7 press release](#) concerning the outcome of the Senate elections and its ties to Kavanaugh.

Judge Kavanaugh was introduced possessing "impeccable credentials, unsurpassed qualifications, and a proven commitment to equal justice under the law" and immediately [CWA hit the ground running](#). CWA's national and state organizations stood steadfast for Kavanaugh [from the very beginning](#) to the end. There was an eight-state [Women for Kavanaugh bus tour](#); CWA staff and state leaders were present at every public hearing, and 400 women prayed and rallied behind the Russell Senate Building during the Kavanaugh hearings at CWA's Women for Kavanaugh event. Some dared to enter the Russell Senate Building and pray in the middle of all the chaos. CWA's CEO and President Penny Nance did [outstanding media](#) throughout the process. President Trump even tweeted about our Women for Kavanaugh efforts in the Capitol.


2018 Year in Review

We cannot end the year without exploring the myriad of ways that together we have left our mark on 2018. We rejoice in all the Lord has allowed us to be part of, because of YOU!

We co-hosted the Pro-Life Training Academy in Matthews with ProLifeOnCampus.com. Dr. Fletcher Armstrong, Director of Southeast Region, Bio-ethical Reform, taught the attendees how to defend and articulate the pro-life position without wavering.



Twice throughout the year, we participated in the 40 Days for Life Campaign with a prayerful and proactive pro-life message at two abortion clinics, one in Raleigh and one in Charlotte.



Three times this year, we partnered with "Love Life" Prayer Walks at the largest abortion clinic in the southeast located in Charlotte, and newly added locations in Raleigh and Greensboro! We are among

thousands of prayer walkers seeking to see an end to abortion in these cities.



In April Jill Coward spoke out against the sex ed curriculum in Charlotte at the Parents Vote Campaign as we stood with parents all across our state who were outraged by activists and bureaucrats using our schools and tax-payer funds to advance their political agendas. Parents were encouraged to hold their children home from school on April 23 in protest of the graphic, immoral sex education of our kids.



In May, June, and July, we covered in prayer all 180 members of the North Carolina General Assembly, Council of State, Governor and Lt. Governor; as well as our U.S. Congressmen and Senators; President and Mrs. Trump as well as Vice President and Mrs. Pence through our Encourage-A-Legislator program in which we mailed them encouragement cards.

In June, we hosted our 18th Annual Day at the Capital in Raleigh where we presented a chapel service in the Legislative Chapel Room with legislators and their staff, visited our legislators thanking them for serving our state, and encouraged them on two issues: 1.) Pass HB575, Require Info

About Abortion Pill Reversal, ensuring that women seeking a chemical abortion have information of the process to reverse the abortion if they change their minds. 2.) Advocated for parents to have the right to know, and have access to, school lesson plans and curriculum involving human sexuality and bullying prevention. It is imperative that our state adopt commonsense educational transparencies to protect our children. Parents have the right to know! (Unfortunately, neither of these issues came up in our last legislative session. We will keep you alert to what the next session holds.)



We joined CWA national and CWA organizations around the country in fiercely defending Judge Brett Kavanaugh's Supreme Court nomination which included e-alerts, op-ed titled [Dems Want to Sabotage Nomination](#), handouts and more.



Thanks to the Trump Administration, new regulations called the **Protect Life Rule** were proposed to shift Title X funds away from abortion clinics instead to authentic life-promoting centers. We vigorously promoted this rule, encouraging our members and friends to speak loudly to our national politicians before the July 31 deadline. We are hoping for a ruling from the Department of Health and Human Services by mid-January.

We hosted **Open Prayer Lines for Human Trafficking Victims** numerous times

throughout the year. We were among other prayer warriors available to take phone calls on the 11th of every month to pray with anyone involved in human trafficking.

We encouraged our members to get out the vote this election season and provided several voting resources including a doc-



ument of the differences between the parties, links to voter guides, information about the constitutional amendments on the ballot, and push cards for them to print and distribute with the line "Mob Rule, or Rule of Law".

We trained a new **Prayer/Action Chapter Leader**. And we will be training three more the first of the year, bringing our total Prayer/Action Chapters to nine state chapters.

Joy of a Prayer/Action Chapter

When I asked her what she has enjoyed as a chapter leader, she answered with a resounding, "It has been wonderful! Jan enthusiastically promotes Penny Nance's book, *Feisty & Feminine: A Rallying Cry for Conservative Women* and said that this is an easy way to get a prayer group started. A few years back, Jan invited women of all ages to meet once per month to talk about Penny's book and pray over each chapter and how it speaks to their own lives. She has given the book to women of all ages and said that the "feedback has all been positive."

This prayer warrior believes that Penny's book is an excellent read for victims of sexual assault and stated that she feels that "we all should be catalysts and prayer warriors because the issues that CWA cares about are on the heart of God."

Prayer chapters can begin with just two women present and grow from there. Jan's group has about six women who attend regularly. Whenever she is at different functions, she is always on the lookout for potential Prayer/Action Chapter members and leaders.

CWA of North Carolina is fortunate to have this dedicated woman serving as a Prayer/Action Chapter Leader in our state. It is our prayer that God will place this desire on the hearts of many women, of all ages across North Carolina, so that more prayers can go up to heaven concerning our seven core issues: 1. Sanctity of Life, 2. Defense of Family, 3. Education, 4. Religious Liberty, 5. National Sovereignty, 6. Sexual Exploitation, and 7. Support for Israel.

Innovative Anti-Human Trafficking Organization Starts

This spring I started a new anti-human trafficking non-profit to address aspects of the work that have been overlooked in our community. While working with different non-profits, I realized that we would not be able to affectively disrupt human trafficking if: 1. We did not start collecting and analyzing more data about trafficking 2. We did not start doing more intervention for our at-risk youth and, 3. We did not educate our communities on the signs and realities of human trafficking. Because of these needs, [The Ursus Institute](#) was created. Ursus is Latin for bear. So, think of The Ursus Institute in relation to this Bible Verse "Bear one another's burdens, and so fulfill the law of Christ" (Galatians 6:2).

It is imperative to have accurate data collection to fight and win this war against women and children. Currently, very biased tools are utilized to gauge human trafficking. For example, if we look at conviction rates of perpetrators in Mecklenburg County, one finds less than 20 since 2014. Because it is difficult to convict a perpetrator, it may look like that given county does not have an issue with this crime. Too often the numbers under-represent the reality as most victims of trafficking do not self-identify and do not know how to call for help. In order to combat this problem, we need to collect unbiased data to present to our General Assembly members in order to write new legislation that is based upon reality.

I am looking forward to working with CWA of North Carolina to wipe out this vast and cruel crime waged upon women and children in our state.

Abortion Pill Reversal: From Regret to Hope

On June 6, CWA of North Carolina gathered for our 18th Annual Day at The Capital in Raleigh visiting our legislators and lobbying on two issues. One specific issue, House Bill 575, is a bill that would require abortion clinics to provide women with information about the possibility of reversing a drug-induced abortion.

Regret. That's the way many women feel after taking the abortion pill, RU-486. I had the opportunity to interview Dr. Matt Harrison, a pioneer of the Abortion Pill Reversal treatment; here is what he had to say about the day he performed the first-ever abortion pill reversal.

"In 2006, a young lady, Ashley, came to my office after having ingested the abortion pill 36 hours earlier. She had been pressured and immediately regretted the abortion. The abortion clinic said she could not do anything and that if she did not follow through with the rest of the abortion procedure that her baby would probably die anyway, but had it lived, it would be physically or mentally handicapped. Because I had done research and published articles on receptor biology regarding Mifepristone, the Abortion Pill, I knew a progesterone blocker could be used. I decided that if we could give extra progesterone, we could probably out-compete the Mifepristone which would only be in her system for about 72 hours. Hopefully enough progesterone functioning would reverse its effects and support the pregnancy. Ashley wanted to try the treatment, so we proceeded. She started to bleed that weekend after the first

treatment but then stopped and her baby survived! Today her daughter is 12 years old and perfectly healthy."

Dr. Harrison continued regarding the effectiveness of the abortion pill reversal:

"A paper was published recently showing a 68% effectiveness rate at reversing chemical abortions when given the proper treatment. (*Issues in Law & Medicine*, Volume 33, Number 1, 2018) Without the reversal treatment, the survival rate of embryos exposed to the mifepristone is only about 25% at best. (*Issues in Law & Medicine*, Spring 2017). Over 500 babies have been saved already using this reversal treatment! I personally have had a few women go through the treatment; but we have over 350 providers that now offer reversal treatment, and we have had over 700 women attempt reversal. So even though it is not extremely common, these numbers are very significant, and each woman should have the right to change her mind and try to save her baby's life!"



We agree with Dr. Harrison – a woman should have the right to save her baby's life! It's important that women are given all information regarding abortion and the abortion pill reversal.
