

Wake Up America: Know Where Your State Stands on Abortion

Below is an overview of state laws (as of February 8, 2019) as they relate to late-term abortion, born-alive protections, and public funding of abortion.

Some states adhere to the *Roe* standard of viability, which is defined by the Supreme Court in *Roe* as "the capacity for meaningful life outside the womb, albeit with artificial aid" and not just "momentary survival." Unless specifically stated otherwise, references to "health" adhere to the definition of health in *Doe v. Bolton*²: "all factors physical, emotional, psychological, familial, and the woman's age—relevant to the well-being of the patient." If a state is listed as "N/A," then there are no state laws regarding either an abortion limit or exceptions. However, these states are subject to the federal precedent of viability in *Roe*, but if *Roe* were overturned, then these states would have no limits on abortion.

A handful of states have passed different versions of the Freedom of Choice Act (FOCA). This bill guarantees a woman's "fundamental right" to abortion access, at varying points in pregnancy, and essentially codifies *Roe*.

While federal funds are prohibited from funding abortion because of the Hyde Amendment, with the exception of rape, incest, or to save the life of the mother, states can use state funds to fund abortions and can do so under whatever circumstances the state determines. Each state with born-alive laws has varying degrees of protections for infants born alive and varying penalties for doctors who cause or allow the death of a born-alive infant. Note: some states have passed more strict abortion laws, but these laws have been enjoined in litigation and are not currently enforced. Whenever possible, these cases have been noted.

This data was obtained and cross-referenced from the Guttmacher Institute,⁴ Americans United for Life,⁵ NARAL,⁶ and the Kaiser Family Foundation.⁷ Any conflicting information was cross-referenced through state statutes and has been noted in the table.
