5/25/21	Lee Amendment to S. 1260	Prohibits funds for research involving fetal tissue or embryo destruction	Supported	Failed
5/25/21	Braun Amendment to S. 1260	Prohibits certain types of human-animal chimeras in federal research	Supported	Failed
6/8/21	H.R. 7 Paycheck Fairness Act (procedural vote)	Redefines sex in fair labor laws to include sexual orientation and gender identity	Opposed	Failed
6/22/21	S. 2093 For the People Act (procedural vote)	Institutes a federal takeover of state voting laws, forces taxpayers to fund political campaigns, and requires nonprofits to disclose donors	Opposed	Failed

8/11/21	Kennedy Amendment to S. Con. Res. 14	Prohibits abortions after 20 weeks, when the child can feel pain	Supported	Failed
8/10/21	H.R. 3684 Invest in America Act	Uses infrastructure projects to promote an ideological agenda, including new federal dictates around "actual and perceived" gender identities	Opposed	Passed
10/20/21	S. 2747 Freedom to Vote Act (procedural vote)	Institutes a federal takeover of state voting laws, opens door for taxpayer-funded political campaigns, and requires nonprofits to disclose donors	Opposed	Failed
11/3/21	S. 4 John R. Lewis Voting Rights Advancement Act (procedural vote)	Subjects state election laws to federal approval under the discretion of Department of Justice political appointees	Opposed	Failed
