

## Standing with Moms in Congress

Since the inception of Concerned Women for America Legislative

Action Committee, advocating for mothers and the unborn has been a top priority on Capitol Hill. This Congress, the Life.Gov Act has been a top priority for us.

With Mother's Day right around the corner, we are focusing on reaching out to every member of Congress to share life.gov with them.

The Life.Gov Act and its Senate Companion, the Standing with Moms Act, were introduced by Congresswoman Diana Harshbarger (R-Tennessee) and Sen. Marco Rubio (R-Florida) late last year. In short, this bill would create a federal clearinghouse titled *life.gov* that would aggregate all local, state, and federal resources that a mother might need during and after an unexpected pregnancy. The website would house information on the local pregnancy resource centers, food banks, clothing banks, lactation consultants, and any other resources that might be pertinent for a mom and her child.

For those who are involved in the pro-life community, it is common

sense to know that there is a plethora of resources available to women and children in need; for those who are not, they might not be aware that there might be a pregnancy resource center in their city. From 2018 to 2022 alone, Planned Parenthood spent \$13.2 million on ads across Meta platforms. The sad reality is that when a woman has found herself in an unexpected pregnancy, she might feel scared and alone. Because she does not know that there are other resources out there, she turns to the only organization she thinks can help her, Planned Parenthood. Life.gov stands in direct contrast to Planned Parenthood by empowering women to choose life.

### **ACTION:**

- Contact your representative here and urge them to cosponsor the Life.Gov Act.
- Contact your senator <u>here</u> and urge them to cosponsor the Standing with Moms Act.

- Pray for the women in your local community who have found themselves in an unexpected pregnancy that they might choose life.

# VA Puts Abortions Ahead of Caring for Veterans

The Department of Veterans Affairs

(VA) is the latest agency to flout the will of the people by focusing on politics rather than its foundational mission. Instead of ensuring America's warfighters are cared for, the VA has just finalized a rule that allows it to provide taxpayer-funded abortions to veterans.

Just three months after the *Dobbs* decision returned the question of abortion to the people through their elected representatives, the VA announced an Interim Final Rule (IFR) that would allow the agency to facilitate abortions at VA medical centers or through community care.

This Rule changes the VA's longstanding exclusion of abortions and abortion counseling from its covered services and flagrantly violates the Veterans Health Care Act, a federal law that has prohibited VA facilities from performing abortions for over 30 years. The agency argues in the Rule that this change is necessary because "as abortion bans come into force across the country, veterans in many states are no longer assured access to abortion services in their communities, even when those services are needed."

Sen. Tommy Tuberville (R-Alabama) has led the charge against this new Rule ever since it was announced. But despite Congress's best efforts, the Rule has now been finalized, so Tuberville's next move, alongside Rep. Mariannette Miller-Meeks (R-Iowa 1), is to introduce legislation that would force the VA to be transparent about abortion services.



passed, Tuberville's bill would require the VA to be transparent about the abortion-related services that it is providing on the government's dime. The bill would force the VA to provide a quarterly report that provides the number of surgical abortions versus abortions via mifepristone or other drugs, the number of weeks at which the abortion was conducted, the exception under which the abortion was justified, the state in which the procedure took place, and the total expenditures for facilitating these procedures.

If the federal government is going to provide taxpayer-funded abortions and, often, in states that have restricted the practice, the least that they can do is provide some relevant data to Congress. Concerned Women for America Legislative Action Committee thanks Sen. Tuberville for his tireless efforts on this front.

**ACT:** Use our <u>action center</u> to contact your Members of Congress and ask them to support the VA Abortion Transparency Act.

**PRAY:** Pray for your Members of Congress by name. Ask the Lord to soften their hearts for the unborn and to seek ways to protect life in and outside the womb.

# GENDER IDEOLOGY Biden's Title IX Tidal Wave

President Joe Biden's Title IX final rule has landed in black and white with an effective date of August 1, 2024. It is a tidal wave threatening to drown 52 years

of civil rights law prohibiting discrimination on the basis of sex.

Title IX of the Education Amendments of 1972 was enacted to ensure equality of opportunity and protections for male and female students in all educational programs and activities, including athletics. For many liberal feminists, Title IX was a consolation



prize in a failed campaign to win the Equal Rights Amendment. But the law was soon embraced across the spectrum as a constructive vehicle for ensuring women's opportunities in academics and athletics.

In large measure, it has succeeded. Female participation in higher education and certain scientific fields now exceeds male counterparts. Some 44% of student-athletes in the National Collegiate Athletic Association (NCAA) today are women. Title IX has been a foundation for many female students to pursue their gifts and passions.

But under Biden's brand of Title IX, trans-identifying men are now the new women. Unlimited "gender identities" have priority for claims of sex discrimination, turning the whole purpose of Title IX for male and female students on its head. Sex-based protections are meaningless if women and girls are no longer protected on the basis of sex.

Pushback from certain states resisting Biden's radical rewrite of Title IX has been swift. Within the first week, superintendents in Louisiana, Oklahoma, Florida, and South Carolina sent letters to school districts instructing them not to comply with Biden's changes. Conflicts with state laws, the illegitimacy of redefining the meaning of "sex" by executive fiat (not Congress), concerns for parental rights, and the harm to students of imposing gender ideology through Title IX mandates are all valid issues for court challenge.

Elections also have consequences. But for now, Biden's Title IX holds the power of federal enforcement and the threat of federal funds, which compel schools to surrender instead of stand firm.

When a tidal wave is coming, the response should be to build a barrier of protection. That barrier is what Concerned Women for America will continue to support in prayer and action as we engage the battle to protect our schools, students, and athletes from Biden's destructive crusade to impose gender ideology through Title IX.


