### **Senators to HHS – Stop Forcing Employees to Deny Reality**


HHS, the taxpayer-funded agency tasked with promoting the health and well-being of Americans, is forcing its employees to deny biological reality or risk being fired. In an <u>email</u> sent to staff in October of 2023, the agency unveiled its HHS Gender Identity Non-Discrimination and Inclusion Guidance which states that all employees must "be addressed by the names and

pronouns they use to describe themselves."

But the policy goes farther than pronouns. The guidance policy not only allows people to use any single-sex

space of their choice, but if other employees are uncomfortable with sharing these spaces, which include restrooms, locker rooms, and lactation rooms, with a member of the opposite sex, the concerned employees will be directed to use other facilities, because the self-identifying "employees will not be barred from using the restroom consistent with their gender identity."

For HHS employees holding on to truth, they are not able to be fully transparent about their beliefs in the workplace. The rights of those who believe in the false religion of gender ideology are more important than the rights of those who strive for honesty and truth, even when based on their own deeply held religious convictions.



That is why Sen. Lankford sent a <u>letter</u> to HHS Sec. Xavier Becerra this past week calling on him to rescind the discriminatory policy. Though HHS says that improper pronoun use creates a hostile work environment, the letter points out that allowing men into women's restrooms does so to a far greater degree. Forcing a woman to be exposed to fully intact male anatomy is far more uncomfortable than using someone's proper pronouns.

Under the current administration, HHS has been weaponized against anyone who believes that men and women are created uniquely and immutably by God. As November approaches, this is a stark reminder that elections have far-reaching consequences. While no one votes for each cabinet secretary, we do vote for the man (or woman) who appoints them.

**PRAY:** As America heads to the polls this season, pray that voters will consider not only the name at the top of the ticket, but those they will select for key positions.

# Teamwork off the court; Nevada Volleyball stands unified against the NCAA


[Because of Macy Petty's <u>experience with the Girls in sports issue</u> we thought it appropriate that she write under the GENDER IDEOLOGY heading for this month's issue. Plus, as you may know, the House has been in recess.]

The University of Nevada Women's Volleyball Team reminded the NCAA they aren't outside of accountability when the team protested a scheduled game against San Jose State University, a

team with a male participant.

With four teams already pulling out of games against SJSU, eyes closely watch the upcoming opponents to see who will follow suit in putting the safety and dignity of their female volleyball players first. University of Nevada told Outkick on October 3 they would play the scheduled Oct 26 game against SJSU.

This didn't sit well with the women who would be competing. Later that month, the team released a <u>statement</u>; "We, the University of Nevada Reno women's volleyball team, forfeit against San Jose State University ... We demand that our right to safety and fair competition on the court be upheld. We refuse to participate in any match that advances injustice against female athletes."



After the women released their statement, the school once again clarified they would still be competing in the game. The team told Outkick they "wouldn't participate in a game that advances sex-based discrimination or injustice against female athletes."

At a standoff, truth prevailed. The girls remained committed to the stand, and the school had no team to send to the match. Rather than competing, they <u>participated</u> in a press conference that afternoon to encourage rule makers to uphold sex-based protections in sports.

Though the NCAA, the Mountain West Conference, and

the University of Nevada all turned their back on these women, their bold and courageous cause reminded the rule makers just how powerfully their voices rise. This game couldn't paint them a clearer picture; they are utterly beholden to the female athletes they govern. There is no game, tournament, or ticket sales if the athletes don't show up.

Because the responsibility to protect the athletes lies in the hands of the NCAA and other athletic administrators, the team's protest condemns those who turned their back on them.

The courage these young women showed cannot go unmentioned.

#### PRAY:

- Pray for each of the Nevada Women's Volleyball Team members by name.
- Pray for their safety, continued boldness, and more opportunities for lasting impact.
- Pray more women follow the footsteps trailblazed by the courageous young women and pull out of dangerous and discriminatory competitions.

ACT: Check the remaining teams immediately on the <u>SJSU's schedule</u>. If you live in one of the states with a university that is playing SJSU, find out who the university's president is and respectfully write to him/her with your concerns.
