Development/Donor Relations

CWA's development department manages key relationships with partners who give financially to the organization.

CWA's grassroots department facilitates the organization's work on the state level, supporting leaders nationwide who further policy initiatives.

Young Women for America (YWA)

Young Women for America is CWA's high school and collegiate leadership program. Leaders around the nation work to advance CWA's efforts on their campuses and their communities through prayer, education, and advocacy.

Communications (Digital & Press)

CWA's communication department spreads the message and efforts of the organization through both online media and print.

Government Affairs/Public Policy

CWA's government affairs department develops policy in alignment with the organization's core issues and builds relationships with elected officials to further policy efforts.

Legal Affairs

CWA's legal department works closely with the government affairs team, developing policy and conducting research to inform the organization's efforts.

Housing & Compensation

Based on semesterly availability, CWA has arranged a partnership with the Heritage Foundation for CWA's interns to share an apartment in the E.W. Richardson Intern Building. The Richardson is conveniently located on Capitol Hill and a 5-minute walk to the Union Station Metro. Interns are responsible for covering housing fees for the duration of the internship.

Interns work full time (40 hours per week) and are paid bi-weekly at the \$12.41 Virginia minimum wage hourly rate, less payroll tax withholdings. Paychecks will be received via direct deposit every other Friday. Any special activities that take place outside of regular CWA office hours are voluntary and will be considered unpaid time.

CWA's Statement of Faith

- We believe the Bible to be the verbally inspired, inerrant Word of God and the final authority on faith and practice.
- We believe Jesus Christ is the divine Son of God, was born of a virgin, lived a sinless life, died a sacrificial death, rose bodily from the dead on the third day and ascended into Heaven from where He will come again to receive all believers unto Himself.
- We believe all men are fallen creations of Adam's race and in need of salvation by grace through personal faith in the Lord Jesus Christ.
- We believe marriage is between one man and one woman, that sexual activity outside of that marriage is sin, and that God created the human race male and female.
- We believe life begins at conception and is to be protected from conception to natural death.

CWA's Seven Core Issues

- Sanctity of Life: CWA supports the protection of all innocent human life from conception until natural death. We also support alternatives to abortion and healing for mothers suffering from the results of abortion.
- Religious Liberty: CWA supports the God-given rights of individuals in the United States and other nations to pray, worship, and express their beliefs without fear of discrimination or persecution.
- Defense of Family: CWA believes that marriage consists of one man and one woman. We seek to protect and support the Biblical design of marriage and the gift of children.
- Sexual Exploitation: CWA endeavors to fight all pornography, obscenity, prostitution, and sex slavery.
- Education: CWA supports reform of public education by returning authority to parents and also accessibility to alternatives forms of education.
- National Sovereignty: CWA believes that neither the United Nations nor any other international organization should have authority over the United States in any area. We also believe the United States has the right and duty to protect and secure our national borders. We believe in budget restraint which embodies responsible spending, small government and a budget in which the U.S. government spends within its means and ceases to steal from future generations.
- Support for Israel: CWA believes that the people and nations who stand with Israel and the Jewish people will be blessed by God. We believe that any foreign policy effort to withdraw U.S. support for Israel is in direct contradiction to America's national interests.
