THE SENATE in Review

CWALAC Applauds the Effort to End Woke Education **Practices**

Gender ideology has been a pervasive problem in the school system for years. Now Congress is acting to stop it.

At least 16 states have laws compelling teachers to include these materials in their lessons. Several of these, including Nevada, mandate that LGBTQ+ inclusive curriculum begin as early as kindergarten. Because some of the states with these laws on the books are the most populous in the country, such as California and New York, nearly 37% of American schoolchildren are subjected to gender propaganda in the classroom, paid for by taxpayers.

Traditionally, parents have been able to opt their children out of classes when sex education material, which they would rather talk to their kids about at home, is presented. But when this ideological indoctrination is in every subject and affects various levels of school policy, it makes it impossible to avoid, short of pulling a child out of the public school system entirely.

One of President Trump's first executive orders was to declare that there are only two sexes, male and female, and that no other ideology would be tolerated across the executive branch or any entities funded by the federal government, which includes public K-12 schools. While Concerned Women for America's Legislative Action Committee applauded that executive order, the reality is that executive orders can be easily overturned by a future president with a different (and erroneous) view of human nature. The only way to ensure that this directive remains the law of the land is for Congress to enact it into law.

That is why Sen. Jim Risch (R-Idaho) and Rep. Owen Burgess (R-Utah 4th) are introducing the Say No to Indoctrination Act. The bill focuses on the portion of the executive order that prohibits federal taxpayer dollars from funding radical

gender ideology in public schools. While it will not prohibit states from requiring schools to promote this ideology, losing funding will be a powerful motivator for public schools to reform.

HOUSE BUSINESS

America Strong

The House of Representatives continues to churn through the Appropriations process with yesterday's passage of the Department of Defense Appropriations Act, 2026 (H.R. 4016). In the bill, the

House advanced several pro-family wins that refocus our military on defense and strategic investments, rather than woke ideological battles.

Ideologically driven political leaders have a history of misappropriating defense spending to further radical social goals, which in turn weaken national security. For example, former President Joe Biden long championed using defense dollars to provide free travel for members of the military seeking abortions.

The Hyde Amendment explicitly prohibits forcing taxpayers to pay for others' abortions, and H.R. 4016 ensures these protections as they relate to military funding.

The Pentagon also has a storied history of drag shows and vaccine mandates, both of which are now explicitly prohibited. And the bill guards taxpayers from having to finance sex trait modification procedures.

The defense appropriations bill also restores unity and strength by loosening the grip of DEI bureaucracy on military officials, quotas for hiring and promotion, and by thwarting standards and expectations in the name of "equity." Related DEI programming and materials were previously considered "core competency," but are now entirely defunded under H.R. 4016.

A new day has dawned. Rather than financing initiatives that weaken our defense and threaten our homeland stability, new leadership has redirected these previously misappropriated funds towards military superiority.



H.R. 4016 OVERVIEW

- \$ 13 billion towards missile and space program development in support of the U.S. Golden Dome effort
- \$1.15 billion to combat international drug trafficking
- \$500 million in the Israeli Cooperative Missile Defense Programs (Iron Dome and others)
- \$ 122.5 million towards U.S.-Israel cooperative development programs

The bill additionally honors the men and women who serve with a 3.8% base pay increase.

The FY26 Defense appropriations bill reclaims the attitudes and purpose of the world's most prestigious defense operation, prioritizing readiness over ideology. <u>See how your representative voted here.</u>
