THE SENATE in Review

The Congressional Fight Over Online Sports Gambling.

(OBBB), the Senate successfully slipped in a provision to curb the growing influence of online sports gambling. But there is currently a misguided, bipartisan push to reverse that policy win.

Prior to the bill's passage, sports bettors could deduct 100% of their losses from their wins. For example, if someone lost \$100,000 but then won \$100,000, they would not owe any tax. This incentivized people to continue placing bets in the hope that they would recoup some of their losses. But starting in 2026, the OBBB narrowly increases the tax on gamblers by changing it from 100% to 90%. Now, the same person in the example above will owe taxes on \$10,000.

Legalized sports gambling increased the risk of a household going bankrupt by 25-30%

This slight change has the potential to significantly impact the appeal of online sports betting, a now ubiquitous activity that is only serving to harm American families. A study conducted by economists from the University of Southern California found that the legalization of sports gambling increased the risk of a household going bankrupt by 25-30%. A separate study from Northwestern University found that legalized sports betting depletes households' savings.

The effects of gambling are not just financial, however. A recent, <u>more alarming study</u> found that in states with legal sports betting, there is a 9% increase in domestic violence, the victims of which are usually women.

All of these effects are compounded by online sports betting. Research suggests that the rate of gambling problems is at least twice as high among online sports bettors as it is among any

other kind of gamblers, which, considering nearly 90% of all bets are now placed online, is very concerning.

Despite these negative consequences of gambling, some members of Congress want to continue supporting the sports betting industry. The FAIR Bet Act currently has six Democrat



cosponsors and four Republicans. Republican cosponsor Troy Nehls (Texas-22nd) has said that the provision in the OBBB is "unfair" and that it is an "overly punitive" tax on gambling, unintentionally revealing how online sports betting is ensnaring more people than ever into a dangerous gambling habit.

CWALAC applauds the important step that Congress took with this provision.

PRAYER

Pray that legislators would find support and stand strong against arguments to reverse this policy and would instead continue to fight against the harms of legalized online sports betting.

ACTION

Create an awareness campaign in your community for the need for gambling addiction support groups. Host a prayer walk for victims of this addiction that can destroy families.

AUGUST 6 Macy Petty's op-ed titled "USA Volleyball's Anti-woman Agenda Lives on, Despite Trump's Executive Order" was featured on Fox News. Her piece exposes USA Volleyball's failures to protect female athletes and discusses the importance of passing Congressman Greg Steube's "Protection of Women in Olympic and Amateur Sports Act."

AUGUST 11 Quoted in a wide array of local media, CWA responded to the chilling discovery that Fairfax County Public Schools arranged and funded students' abortions in 2021, calling it "an absolutely outrageous affront to parental rights." Penny Nance also posted a video to social media that was featured here in *The Daily Signal*.

AUGUST 13 Penny appeared on the <u>Chris Plante Show on Newsmax</u>, providing commentary on President Trump's anti-crime push in D.C., peace talks, and men in women's sports.

AUGUST 19 Penny was quoted in numerous publications, including *The Week*, cheering Costco's decision to no longer stock the abortion pill. Additionally, she noted that mifepristone has "also been used on unsuspecting women by predatory men, making it possible that lawsuits could be filed against businesses who sell the abortion pill — one more reason Costco's decision is wise"— a reference to the horrifying news story about a Texas woman suing a man for lacing her hot chocolate with at least 10 mifepristone pills, forcing her to abort their unborn child. CWA made an <u>Instagram reel</u> sharing that story.

AUGUST 20 Penny responds to <u>World Boxing's announcement</u> that they will require mandatory sex testing in the women's catagory, "World Boxing is leading the way on the international stage to restore the veracity and integrity of sex-based categories of sport. Their decision to enact mandatory sex testing is a victory for women's safety and dignity," said Penny Nance, CEO and President, Concerned Women for America. AUGUST 21 Former educator and Athletic Director, State Director of New Mexico, Nickie McCarty, responds to the news that New Mexico's ranking among states with protections for religious liberty has fallen from 11th to 26th in only a year in the New Mexico Sun.

AUGUST 21 Doreen Denny, CWA Senior Advisor, wrote a <u>scathing response</u> to the situation at Indiana University and other colleges around the country for *Townhall*. "College policies can result in women being assigned to share campus housing with students declaring they are "women" or "nonbinary," but are male."

The Federal Trade Commission Aims to Tackle Deceptive Practices

The Federal Trade Commission (FTC) has a statutory mission to protect the public from deceptive and unfair business practices. With that kind of mandate, the possibilities for action in a society held hostage by scams, false advertising, and fraudulent behavior could be endless.

Cracking down on the exploitation of vulnerable populations is a top priority, which is why new leadership at the FTC conducted a day-long <u>workshop in July</u> on the dangers of so-called "gender-affirming care" (GAC) for minors.

In follow-up to this workshop, which raised alarming issues, the FTC is poised to act. Its first objective is soliciting experiences, examples, and evidence from the public, "to better understand how consumers may have been exposed to false or unsupported claims about 'gender-affirming care,' especially as it relates to minors, and to gauge the harms consumers may be experiencing."

This invitation for public comments, with a deadline of September 26, is a key opportunity. For years, CWA has been actively sounding the alarm about the deception and harm of social and medical "gender transition" that rejects our God-given design and tells children they can change their identities and recreate their bodies in their own image. Promoters peddle GAC as "health care," despite the destructive impact on human development. They spew false mantras like a child can be "born in the wrong body," and people can "change their sex."

Practitioners, entities, and institutions promoting or providing GAC are the target of this inquiry. The FTC is seeking personal accounts of interactions with individuals or organizations recommending GAC, as well as information about those making false representations regarding the benefits or effectiveness of GAC and/or promoting or advertising GAC procedures or products.



The FTC has provided a guidance document with specific questions of interest: Request for Public Comment Regarding "Gender-Affirming Care" for Minors. Please consider how you can support this action. Any examples you can provide will be valuable to the FTC's critical work.

PRAYER Pray against the deception of GAC. "But the serpent said to the woman, 'You will not surely die ...'" (Genesis 3:4)

ACTION Use <u>CWA's Action Center</u> to send comments directly to the FTC before the September 26 deadline.

Protecting Kids Online

In the ever-expanding technology landscape, inadequate protections for children online jeopardize young innocence and undermine the heart of American families.

Congresswoman Mary Miller (R-Illinois-15th) is leading the charge to protect kids online, and she is looking for support from fellow members of Congress.

The <u>Shielding Children's Retinas from Egregious Exposure</u> on the <u>Net (SCREEN) Act</u> would help protect children from encountering porn online by strengthening age restriction mandates on porn websites. Technological advances give us the capability for simple yet accurate age verification, and we must utilize these tools to protect children online.

Congresswoman Miller and Sen. Mike Lee (R-Utah) sponsored the SCREEN Act in the 118th Congress, but neither chamber brought the bill to the floor for a vote. Thankfully, Concerned Women for America Legislative Action Committee's (CWALAC) allies on the Hill say the bill has garnered significant attention and could even move through committee soon.

Concerned Women for America CWALAC has long supported the SCREEN Act, and we are urging Congress to make it a priority.

Statistics from the <u>National Center for Sexual Exploitation</u> suggest:

- 73% of 13–17-year-old children have consumed pornography
- 54% were exposed at 13 years old or younger
- 52% saw violent pornography including choking, pain, or the appearance of rape



The damages caused by this exposure are considerable. Pornography at a young age is linked to sexual exploitation and aggression, general aggressive behavior, earlier sexual intercourse, poor academic achievement, mental health issues, prostitution, and more.

Children often first see pornographic materials accidentally while browsing the internet. This is due to the lack of age protections that allows easily



accessible pornographic material in everyday scrolling.

The SCREEN Act currently has 15 cosponsors in the House, but the more cosponsors a bill has, the more likely it is to move to a final vote.

Psalm 82:3-4 instructs, "Deliver the poor and needy; Free them from the hand of the wicked."



My CWA Story

I first learned about Concerned Women for America (CWA) in October of 2021.
I had recently uprooted much of my life, seeking opportunities to engage in politics as a young Christian woman. I changed my academic major, transferred schools, and added a year to my college journey—all because I felt God calling me toward something greater. He provided in every way, placing me exactly where I needed to be when I discovered CWA. I didn't yet understand what it meant to be

"conservative" or align with a political party. All I knew was that I wanted to stand for Biblical values and constitutional principles.

When I arrived at my new school, I was hoping to find friends who shared my values. I ended up connecting almost instantly with three amazing women who had all been involved with Young Women for America (YWA)

as leaders. Though intrigued, it was not until I received a personal invite that I made time in my schedule to attend a meeting. That October, the Liberty YWA chapter hosted an event called "Life & Liberty," where we heard from pro-life leaders, including our CWA CEO and President, Penny Nance. Penny was personal, engaging, and a champion of YWA. While speaking with her one-on-one, she encouraged me to plug into the work God was doing in the fight for life and with CWA.

Very quickly, God made it clear that He was leading me to engage with CWA. Without hesitation, I joined YWA on my new campus and immersed myself in the

mission of prayer, education, and advocacy. Within a year, I was speaking to the media on behalf of pro-life students, attending the Dobbs v. Jackson Women's Health Supreme Court rally, joining the Liberty University chapter leadership team, and even testifying on behalf of girls' sports legislation. Advocacy gave me a way to live out the convictions I'd long held, but what truly emboldened me were the relationships formed through the local CWA Prayer/Action Chapters composed of women older than me in years.

These women I built relationships with weren't just allies in the cause—they were mentors and teachers. They guided us in wisdom and discernment, teaching us to live with purity (Titus 2:5) and to stand boldly for truth (Titus 2:7–8). We prayed fervently for our nation's leaders, and then we stood together—for truth on our campuses, in our cities, and in our statehouses. Together we confidently prayed for God to soften the hearts of our nation's leaders, as we stood for truth on our campuses, in our cities, and in state offices.

God created the Church and called us to stand together. As a young leader, what I needed most was not the media appearances or events to

attend - what I needed was and is Godly women who trusted the Lord in ways I never had. What I needed were the prayers with Prayer/Action Chapter Leader, Anne Robeson, before testifying in the Virginia Education Committee. What I needed was the car ride conversations with Teresa Pregnall, reminding me of the faithfulness of God.
